# Structured Evaluation Guidelines for the Assessment of Thesis

### 1. Objective/s of thesis in FCPS course?

- To conduct research work as thesis.
- To develop skill of retrieving research publication.
- To utilize research findings in their daily practice life.
- To transfer evidence based practice in clinical settings.
- To write a scientific research paper.

## 2. Scoring/grading/marking method?

- At present a thesis work and submission before speculated time is mandatory.
- Successful defense of it is a pre-requisite to appear in the FCPS (Final) examination.
- Marks as grades are given both for writing and thesis defense but those are transformed into "eligibility" only.
- Grade obtained are not in the final mark sheet, not even the successful completion of the thesis defense.
