MTI Interviews: Thursday 22nd February 2024, Dhaka

Under the auspices of the Academy of Medical Royal Colleges' Medical Training initiative (MTI) scheme, NHS England – East of England (EoE) welcome applications from Bangladeshi trainees to train for up to 2 years in registrar (ST3+) and core (ST1-2) level training posts in the region. The scheme is in the process of being extended to other regions too.

We have work and training opportunities available in the following speciality areas in a number of hospitals across our constituency:

- Accident and Emergency Medicine
- Anaesthetics
- Critical Care
- Obstetrics & Gynaecology
- Ophthalmology
- Paediatrics
- Psychiatry
- Radiology (Clinical and Medical)
- Surgery – including General Surgery, Trauma & Orthopaedics, ENT, Cardiothoracic surgery (ST1 level)
- Medicine – including Acute/Internal Medicine, Dermatology, Diabetes & Endocrinology, Gastroenterology & Hepatology, Genitourinary Medicine, Geriatric Medicine, Haematology, Infectious Diseases, Neurology, Oncology, Palliative Care Medicine, Renal Medicine, Respiratory Medicine, Rheumatology, Stroke.

Trainees interested in other specialities may also be able to be accommodated. NHS England EoE is one of 13 “deaneries” in the country that is responsible for postgraduate medical training. It is home to world-famous academic institutions such as Cambridge University and offers a wide range of excellent learning and training opportunities, including a regional induction and “on-boarding” programme – please see the website for further details: <https://heeo.hee.nhs.uk/>

To be eligible for the MTI scheme, you will need to fulfil the following criteria:

- Hold a primary medical qualification recognised by the UK's General Medical Council and be a citizen of Bangladesh.
- Have passed the Academic IELTS within the last 2 years with minimum scores of 7.5 overall and 7.0 in each of the categories OR the Occupational English Test (OET) with a minimum of grade B in all categories. If a confirmed date for the exam is pending, that will also suffice but those already holding this mandatory qualification will be prioritised.
- Be in clinical practice for at least 3 out of the last 5 years including being in a continuous employment/training post for the last 12 months

- Hold an appropriate Bangladeshi postgraduate qualification (e.g. MD in Medicine or MS in Surgery, FCPS or part there of if applying for “core level” posts)
- Possess the skills, competencies and understanding of your speciality equivalent as a minimum to a UK graduate towards the end of core training (SHO-level and above).

Please note, the Medical Training Initiative enables participants to work and train in the UK for a maximum of 2 years and is designed to support trainees who will return to their home countries after completing the fellowship. For further details, please see:
